*Re: COMPULSORY CONVERSION NOTICE OF ANIMA BOND FLEX – SHARE CLASS CLASSIC B (IE00BNXH7M95) TO ANIMA BOND FLEX – SHARE CLASS R (IE00BNXH7H43)*

Dear Shareholder,

We are writing to you regarding your investment in ANIMA Bond Flex (the "Fund"), a sub-fund of ANIMA Funds plc (the "Company") managed by ANIMA SGR S.p.A. (the "Manager").

*For avoidance of doubt, defined terms used in this letter that are not defined herein, shall have the meaning ascribed to them in the Prospectus of the Company.*

We inform you that the Share Class you are invested in, namely the Share Class Classic B of ANIMA Bond Flex (the "**Original Class**"), will be converted into the Share Class R of ANIMA Bond Flex (the "**New Class**").

In accordance with the provision of the Memorandum and Articles of Association of the Company headed "*Conversions*" and the provision of the Prospectus of the Company headed "*Compulsory Conversion of Shares*", the Company, in conjunction with the Manager, with the aim to benefit investors savings and reduce the fixed costs being incurred by the Original Class, has decided to compulsorily convert, without any action on your part, all shares in issue of the Original Class into the New Class. In this regard, the New Class has lower investment management fees compared to the Original Class: 1.00% as compared to 1.80%.

The compulsory conversion from the Original Class into the New Class shall take place on **26 February 2026** (the "Dealing Day").

Please be informed that, in order to facilitate the compulsory conversion, subscriptions into the Original Class shall be accepted until 20 February 2026.

Alternatively, if you wish, during the four calendar weeks following this notice you may convert your shares out of the Fund to another sub-fund of the Company or redeem your shares. Should you decide to redeem your shares, the redemption may be subject to such fees as are disclosed in the application form for the purchase of shares by Italian retail investors.

For the avoidance of doubt, a conversion fee will not be applied by the Company in respect of the above-mentioned compulsory conversion.

The Key Information Document ("KID") of the New Class is attached.

## What is this product?

**Type:** The Fund is a sub-fund of ANIMA Funds plc (the "Company"), an open-ended investment company with variable capital incorporated in Ireland and authorised by the Central Bank of Ireland as a UCITS. The assets of the Fund are segregated from those of other sub-funds and cannot be used to pay the debts of other sub-funds of the Company.

**Term:** The Company has an unlimited life and there is no maturity date for this Fund.

**Investment Objective:** The objective of the Fund is to provide medium-term capital appreciation. The Fund is actively managed without reference to any benchmark.

The entire portfolio may be invested in Debt Instruments and/or Money Market/ Short Term Instruments. The Fund may invest up to 50% of its net asset value in non-investment grade or unrated Debt Securities.

The Fund may invest up to 30% of its net asset in emerging markets, including Russia.

The Fund may invest up to 10% of its net assets in Collective Investment Schemes.

The currency exposure is actively managed. The Fund is exposed to exchange rate risk.

The Fund may enter into stock lending arrangements for efficient portfolio management purposes, and/or may use Financial Derivative Instruments for (i) hedging, (ii) risk reduction and/or (iii) investment purposes. The Fund may use financial leverage to increase the amount invested in financial instruments to twice the value of the Fund's net asset value. This means that if there are changes in the prices of the financial instruments the Fund could either gain or lose twice as much as it would gain or lose without using financial leverage.

No dividend is payable on the Shares. Income earned by the Fund will be retained by the Fund and will be reflected in the value of your Shares.

**Intended retail investor:** This Fund is suitable for retail and institutional investors identified on the basis of the following characteristics:

- is an Investor willing to keep the investment for a period of time in line with the Recommended Holding Period; accordingly, the Fund is suitable for Investors with a time horizon medium;
- is an Investor who can bear total capital loss as the Fund is not guaranteed and has a medium-low risk class and a medium-low risk tolerance;
- is an Investor looking for capital growth.

The Depositary of the Fund is State Street Custodial Services (Ireland) Limited.

## What are the risks and what could I get in return?

### Risk indicator



The risk indicator assumes you keep the Fund for 5 years, in accordance with the recommended holding period. The actual risk can vary significantly if you cash in at an early stage and you may get back less. You may not be able to sell your product easily or you may have to sell at a price that significantly impacts on how much you get back. The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you. We have classified this product as 3 out of 7, which is a medium-low risk class. This rates the potential losses from future performance at a medium-low level, and poor market conditions are unlikely to impact the capacity to repay the initial capital amount invested.

Other risks that are materially relevant to the Fund and which are not adequately captured in the summary risk indicator:

- **Credit Risk:** the risk that the issuer of a debt instrument may default, in whole or in part, on its obligation to repay the full capital amount invested and/or the interest thereon;
- **Risks associated with investing in derivative financial instruments:** the risk that the strategies implemented through the use of derivative financial instruments may cause substantial losses.

## What happens if ANIMA SGR S.p.A. on behalf of the Fund is unable to pay out?

The PRIIP Manufacturer has no obligation to make any payment to you. The Company is not required to make any payment to you in respect of your investment. If the Company shall be wound up or dissolved, the assets available for distribution among the holders of the participating shares shall be distributed in accordance with the respective interests in the respective sub-funds. There is no compensation or guarantee scheme in place that applies to the Company and, if you invest in the Company, you should be prepared to assume the risk that you could lose all of your investment.

## What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

### Table 1 - Costs over time:

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and, if applicable, how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario;

## How long should I hold it and can I take money out early?

### Recommended holding period: 5 years

The Recommended Holding Period is defined according to the Fund's objectives, investment characteristics and risk profile. You can ask the Fund to buy back your Shares on any business day, in accordance with the provisions of the Prospectus, whether full or partial repayment of the Shares held is required.

Any exit from the Fund before the end of the recommended holding period could have an impact on the risk or performance profile. There are no early exit costs to pay, however, the relevant Local Paying Agent may charge other expenses.

## How can I complain?
