ANIMA Holding: April 2019 net inflows

Net inflows (excl. Class I insurance): -€220 million
Net inflows insurance business (Class I): -€68 million

Total AuM month-end €178 billion

ANIMA Group recorded in April 2019 negative net inflows for around €220 million (excluding Class I insurance mandates), with total ytd net inflows negative for €212 million.

Regarding the traditional life insurance business (Class I), net inflows is negative for around €68 million, with total ytd net inflows negative for €163 million.

At the end of April, total asset under management of ANIMA Group is around €178 billion, also thanks to a weighted average performance of mutual funds of +5.2% since the beginning of the year.

"At the moment net flows remain weak, as retail customers are still very cautious in their investment choices despite the very good performances granted by our products in the early months of 2019. We believe that, persisting favorable market conditions, there will be an improvement for net new money, both on the retail and on the institutional segment with specific reference to the insurance component", commented Marco Carreri, CEO of ANIMA Holding.
