### ANIMA Holding: January 2020 net inflows

ANIMA Group recorded in January 2020 positive net inflows for around €52 million (excluding Class I insurance).

At the end of January, total asset under management of ANIMA Group is ca. €189 billion, approx. €3 billion higher than the end of 2019.

*"The first month of the year was characterized by profit taking and repositioning by our clients after a year which recorded very strong returns", commented Marco Carreri, CEO of ANIMA Holding. "The net new money remains positive, even if lower than in the last month of 2019. We anticipate however positive impacts on the commercial activity in the coming months also thanks to the revitalization of the PIR products and to our new ESG-driven product range; we are currently carrying out the training and support activities for our main distributors before the start of their placement".*
