### ANIMA Holding: June 2020 net inflows

- Net inflows (excl. Class I insurance): -€125 million
- Total AuM month-end over €183 billion

Milan, 3 July 2020

ANIMA Group recorded in June 2020 net outflows for around €125 million (excluding Class I insurance), for a total amount year to date positive for around €574 million.

This figure does not include a new institutional mandate awarded for around €500 million which will be accounted in July's flows with the securities selection and the portfolio allocation.

At the end of June, total asset under management of ANIMA Group is in excess of €183 billion, declining from €185 billion at the end of 2019 but some €7 billion higher than the end of March 2020.

"In June the strategic partners gradually resumed the normal activity of the branches but, also as a consequence of the conservative approach of clients in this particular moment, it's early to talk about productivity in line with the potential that our distribution networks can express. On the institutional side, during the month we recorded portfolio repositioning by some customers; however, it should be noted that a new important mandate which will begin the operations in the current month is not included in the June flows", commented Alessandro Melzi d'Eril, CEO of ANIMA Holding.
