ANIMA Holding: May 2019 net inflows

- Net inflows (excl. Class I insurance): -€444 million
- Total AuM month-end €176 billion

## Milan, 5 June 2019

ANIMA Group recorded in May 2019 negative net inflows for around  $\notin$ 444 million (excluding Class I insurance mandates), with total ytd net inflows negative for  $\notin$ 656 million. The figure does not include the orders of new *Unit-linked* and *Sicav* products, for ca.  $\notin$ 200 million, which will be accounted in June's inflows together with the additional flows which will be recorded during the month.

At the end of May, total asset under management of ANIMA Group is around €176 billion.

"Also in May flows remain weak and well below our expectations due to the increased instability and uncertainty of the environment, not only at domestic level. At the same time, we underline that the current slowdown in organic growth is fully in line with the performance of the Italian AM industry, and it is coherent with the cyclical nature of the asset management business. However, this moment should not overshadow the long-term growth potential of the industry, which remains great, especially in Italy where there is huge stock of households' financial wealth and an increased amount of liquidity on bank accounts that we believe should find a more efficient allocation. In this regard, we will shortly launch Anima PrimoPasso, a new solution with a risk/return profile particularly suitable for retail customers approaching AM products" commented Marco Carreri, CEO of ANIMA Holding.
