### ANIMA Holding: March 2024 net inflows

- Net inflows (ex Class I insurance mandates): € -94 million
- Total AuM at the end of the month over €193.5 billion

Net inflows recorded by ANIMA Group in the month of March amounted to € -94 million (ex class I insurance mandates).

To allow for a better evaluation of the economic effect of net inflows, starting with this month ANIMA discloses the component related to **funds underlying funds**, whose profitability is limited and in many cases cancelled by the prohibition of fee duplication, as per Italian regulations.
