ANIMA Holding: November 2018 net inflows

- Net inflows (excl. Class I insurance): +€68 million
- Net inflows insurance business (Class I): -€4 million
- Total AuM month-end €172 billion

## Milan, 10 December 2018

ANIMA Group recorded in November 2018 positive net inflows for around  $\in 68$  million (excluding Class I insurance mandates), with total ytd net inflows positive for  $\in 1.1$  billion; total assets under management exceeded at the end of the month  $\in 90$  billion, with approx. 28% increase compared to AuM at the end of November 2017.

Regarding the traditional life insurance business (Class I), net inflows is negative for around €4 million with AuM at €82 billion.

At the end of November, total asset under management of ANIMA Group is over €172 billion.

"November ended with a positive figure for net inflows; in such an environment of high volatility and uncertainty, it's been fundamental to have significantly differentiated our range of investment solutions for the different distribution channels. In this sense, from this month the Class I insurance business recorded an important increase as a result of the transfer of the mandates of Poste Italiane Group", commented Marco Carreri, CEO of ANIMA Holding.
