ANIMA Holding: June 2018 net inflows.

Milan, 6 July 2018

ANIMA Group recorded in June 2018 negative net inflows for around €473 million; total assets under management reached at the end of the month around €92.5 billion, with approx. 23% increase yoy.

As anticipated in the press release dated June 8^{th} 2018, the June inflows were affected by further disinvestments by a single institutional client for around \in 0.2 billion.

Net of the aforementioned outflows, which amounted to around \in 1.2 billion in May and June (inclusive of the wrap component), first half net new money was positive for approximately \in 0.8 billion.

"Inflows in June were affected by the adverse conditions and the high volatility of the financial markets, which led to a more cautious attitude on the part of distributors and customers, as well as by the expected disinvestment of a single institutional client", commented Marco Carreri, CEO of ANIMA Holding and ANIMA Sgr.

"Looking forward to the rest of the year, we are extremely confident in a positive second half, also thanks to the contribution expected from the new partnership agreements signed in recent months and which are becoming effective, as demonstrated by the completion of the acquisition, from Banca Aletti S.p.A., of mandates for the delegated management of $\in 9.4$ billion" (see the press release dated June 29^{th} 2018).
