What is this product?

Type: The Fund is a sub-fund of ANIMA Funds plc (the "Company"), an open-ended investment company with variable capital incorporated in Ireland and authorised by the Central Bank of Ireland as a UCITS. The assets of the Fund are segregated from those of other sub-funds and cannot be used to pay the debts of other sub-funds of the Company.

Term: The Company has an unlimited life and there is no maturity date for this Fund.

Investment Objective: The objective of the Fund is to seek to provide medium to long term capital appreciation.

The Fund is actively managed without reference to any benchmark.

The Fund will invest globally, mainly in a diversified portfolio of fixed and/or floating rate transferable debt securities of all types (including, but not limited to corporate debt securities, bonds and notes (including inflation linked bonds), zero-coupon and discount bonds, debentures, commercial paper) which are listed or traded on any Recognised Exchange and issued by sovereign, government agencies and/or supranational entities and/or corporate issuers. It is expected that a majority of the Fund's net assets will be invested in a diversified portfolio of corporate debt securities, either directly or up to 10% of net assets through investment in Collective Investment Schemes, and up to 100% of its entire portfolio may be invested in corporate debt securities.

The Fund may gain an exposure of up to 100% of net assets in instruments which are below investment grade or which are unrated at the time of purchase or which, in the opinion of the Manager, are of comparable quality.

In certain circumstances, the Fund may invest up to 30% of its entire portfolio in money market instruments.

The Fund's exposure to non-Euro currencies will generally be hedged, to maintain a low exposure to non-Euro currencies.

The Fund may use Financial Derivative Instruments for (i) hedging, (ii) risk reduction and/or (iii) investment purposes. The Fund may use financial leverage to increase the amount invested in financial instruments to twice the value of the Fund's net asset value. This means that if there are changes in the prices of the financial instruments the Fund could either gain or lose twice as much as it would gain or lose without using financial

The Directors of ANIMA Funds plc may decide to declare distributions which may be paid out of the capital of the Fund. Distributions, if declared, will be distributed on an annual basis

Intended investor: This Fund is suitable for institutional investors identified on the basis of the following characteristics:

- O is an Investor willing to keep the investment for a period of time in line with the Recommended Holding Period; accordingly, the Fund is suitable for Investors with a time horizon medium;
- O is an Investor who can bear total capital loss as the Fund is not guaranteed and has a low risk class and a low risk tolerance;
- is an Investor looking for capital growth and capital income.

The Depositary of the Fund is State Street Custodial Services (Ireland) Limited.

What are the risks and what could I get in return?





The risk indicator assumes you keep the Fund for 5 years, in accordance with the recommended holding period. The actual risk can vary significantly if you cash in at an early stage and you may get back less. You may not be able to sell your product easily or you may have to sell at a price that significantly impacts on how much you get back. The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you. We have classified this product as 2 out of 7, which is a low risk class. This rates the potential losses from future performance at a low level, and poor market conditions are very unlikely to impact the capacity to repay the initial capital amount invested. The Fund is considered to have a materially relevant liquidity risk, because you will not be able to sell your product easily or you may have to sell it at a price that significantly impact on how much you get back.

Other risks that are materially relevant to the Fund and which are not adequately captured in the summary risk indicator:

Credit Risk: the risk that the issuer of a debt instrument may default, in whole or in part, on its obligation to repay the full capital amount invested and/or the interest thereon.

This product does not include any protection from future market performance so you could lose some or all of your investment.

The Unfavourable scenario occurred for an investment of the product between October 2017 and October 2022.

The PRIIP Manufacturer has no obligation to make any payment to you. The Company is not required to make any payment to you in respect of your investment. If the Company shall be wound up or dissolved, the assets available for distribution among the holders of the participating shares shall be distributed in accordance with the respective interests in the respective sub-funds. There is no compensation or guarantee scheme in place that applies to the Company and, if you invest in the Company, you should be prepared to assume the risk that you could lose all of your investment.

What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and, if applicable, how well the product does. How long should I hold it and can I take money out early?

Recommended holding period: 5 years
The Recommended Holding Period is defined according to the Fund's objectives, investment characteristics and risk profile.
You can ask the Fund to buy back your Shares on any business day, in accordance with the provisions of the Prospectus, whether full or partial repayment of the Shares held is required.

Any exit from the Fund before the end of the recommended holding period could have an impact on the risk or performance profile.

How can I complain?
