ANIMA Italian Small Mid Cap Equity (the "Fund"), a sub-fund of ANIMA Funds plc. I Class Shares ISIN: IE00BZBXFQ35 (the "Shares")

ANIMA Funds plc has appointed ANIMA SGR S.p.A. as its UCITS management company (the "Manager" or the "PRIIP Manufacturer"). The Manager is part of the Banco BPM Banking Group.

This Fund is authorised in Ireland and regulated by the Central Bank of Ireland. The PRIIP Manufacturer is authorised in Italy and regulated by Bank of Italy.

What is this product?

Type: The Fund is a sub-fund of ANIMA Funds plc (the "Company"), an open-ended investment company with variable capital incorporated in Ireland and authorised by the Central Bank of Ireland as a UCITS. The assets of the Fund are segregated from those of other sub-funds and cannot be used to pay the debts of other sub-funds of the Company.

Term: The Company has an unlimited life and there is no maturity date for this Fund.

Investment Objective: The objective of the Fund is to provide long-term capital appreciation.

The Fund is actively managed in reference to its Benchmark.

The Fund invests mainly in equities issued by companies listed on Italian Recognised Exchanges and/or considered by the Manager to be Italian companies and which are listed or traded on other Recognised Exchanges.

Exposure to exchange rate risks will be low.

The Fund's aggregate exposure to money market instruments, fixed and/or floating rate transferable debt securities and convertible bonds will not exceed 30% of Fund's net assets.

Up to 20% of Fund's net assets may be invested in equity securities issued by companies of an OECD Member State other than Italy and not listed or traded on Italian Recognised Exchanges.

The Fund may enter into stock lending arrangements for efficient portfolio management purposes, and/or may use Financial Derivative Instruments for (i) hedging, (ii) risk reduction and/or (iii) investment purposes. The Fund may use financial leverage to increase the amount invested in financial instruments to twice the value of the Fund's net asset value. This means that if there are changes in the prices of the financial instruments the Fund could either gain or lose twice as much as it would gain or lose without using financial leverage.

Benchmark: 95% MSCI Italy Small Cap (Gross Total Return - in Euro); 5% ICE BofA Euro Treasury Bill (Gross Total Return - in Euro).

Degree of discretion with respect to the Benchmark: the investment strategy will restrict the extent to which the portfolio holdings may deviate from the Benchmark. This deviation may be significant. This is likely to limit the extent to which the Fund can outperform the Benchmark.

No dividend is payable on the Shares. Income earned by the Fund will be retained by the Fund and will be reflected in the value of your Shares.

Intended retail investor: This Fund is suitable for retail and institutional investors identified on the basis of the following characteristics:

- is an Investor willing to keep the investment for a period of time in line with the Recommended Holding Period; accordingly, the Fund is suitable for Investors with a time horizon long;
- is an Investor who can bear total capital loss as the Fund is not guaranteed and has a medium-high risk class and a medium-high risk tolerance;
- is an Investor looking for capital growth.

The Depositary of the Fund is State Street Custodial Services (Ireland) Limited.

What are the risks and what could I get in return?

Risk indicator



The risk indicator assumes you keep the Fund for 7 years, in accordance with the recommended holding period. The actual risk can vary significantly if you cash in at an early stage and you may get back less. You may not be able to sell your product easily or you may have to sell at a price that significantly impacts on how much you get back. The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you. We have classified this product as 5 out of 7, which is a medium-high risk class. This rates the potential losses from future performance at a medium-high level, and poor market conditions will likely impact the capacity to repay the initial capital amount invested. The Fund is considered to have a materially relevant liquidity risk, because you will not be able to sell your product easily or you may have to sell it at a price that significantly impact on how much you get back.

This product does not include any protection from future market performance so you could lose some or all of your investment.

The Unfavourable scenario occurred for an investment of the product between December 2024 and December 2025.

The Moderate scenario occurred for an investment of the product between October 2016 and October 2023.

The Favourable scenario occurred for an investment of the product between December 2018 and December 2025.

The Stress scenario shows what you might get back in extreme market circumstances.

If the Company shall be wound up or dissolved, the assets available for distribution among the holders of the participating shares shall be distributed in accordance with the respective interests in the respective sub-funds. There is no compensation or guarantee scheme in place that applies to the Company and, if you invest in the Company, you should be prepared to assume the risk that you could lose all of your investment.

What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

Table 1 - Costs over time:

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and, if applicable, how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario;
- 10,000 Euro is invested.

(*) This illustrates how costs reduce your return each year over the holding period. How long should I hold it and can I take money out early?

Recommended holding period: 7 years

The Recommended Holding Period is defined according to the Fund's objectives, investment characteristics and risk profile. You can ask the Fund to buy back your Shares on any business day, in accordance with the provisions of the Prospectus, whether full or partial repayment of the Shares held is required. Any exit from the Fund before the end of the recommended holding period could have an impact on the risk or performance profile.

How can I complain?
