Purpose This document provides you with key information about this investment product. It is not marketing material. The information is required by law to help you understand the nature, risks, costs, potential gains and losses of this product and to help you compare it with other products.

Product

ANIMA Italian Small Mid Cap Equity - Class Silver

ANIMA Italian Small Mid Cap Equity (the "Fund"), a sub-fund of ANIMA Funds plc. Silver Class Shares ISIN: IE00BZBXFP28 (the "Shares")

This Fund is authorised in Ireland and regulated by the Central Bank of Ireland. The PRIIP Manufacturer is authorised in Italy and regulated by Bank of Italy.

What is this product?

Type: The Fund is a sub-fund of ANIMA Funds plc (the "Company"), an open-ended investment company with variable capital incorporated in Ireland and authorised by the Central Bank of Ireland as a UCITS. The assets of the Fund are segregated from those of other sub-funds and cannot be used to pay the debts of other sub-funds of the Company. Shares in the Fund may qualify as eligible investments under the "Piano Individuale di Risparmio a lungo termine" (PIR) pursuant to the Italian 2017 Budget Law (Law No. 232 of 11 December 2016) and to the Italian Law No. 157 of 19 December 2019.

Term: The Company has an unlimited life and there is no maturity date for this Fund.

Investment Objective: The objective of the Fund is to seek long-term capital appreciation.

The Fund is actively managed in reference to its Benchmark.

The Fund shall invest at least 70% of its assets in equity instruments, REITs and SPACs issued by, or entered into, with companies resident in Italy or in a EU or EEA Member State with a permanent establishment in Italy. At least 25% of these equity instruments, which corresponds to 17,5% of the Fund's assets, shall be issued by companies which are not listed in the FTSE MIB index or in any other equivalent indices and another 5% of these equity instruments, which corresponds to 3,5% of the Fund's assets, shall be issued by companies which are not listed in the FTSE MIB index or in any other equivalent indices and another 5% of these equity instruments, which corresponds to 3,5% of the Fund's assets, shall be issued by companies which are not listed in the FTSE MIB Index and FTSE Italia Mid Cap index or in any other indices equivalent to the FTSE MIB Index and FTSE Italia Mid Cap index.

The Fund cannot invest (i) more than 10% of its assets in financial instruments issued by, or entered into with, the same company, or companies belonging to the same group; and (ii) in financial instruments issued by companies which are not resident in countries that allow an adequate exchange of information with Italy. The Fund's aggregate exposure to money market instruments, fixed and/or floating rate transferable debt securities and convertible bonds will not exceed 30% of Fund's net assets.

The Fund may enter into stock lending arrangements for efficient portfolio management purposes, and/or may use Financial Derivative Instruments for (i) hedging, (ii) risk reduction and/or (iii) investment purposes. The Fund may use financial leverage to increase the amount invested in financial instruments to twice the value of the Fund's net asset value. This means that if there are changes in the prices of the financial instruments the Fund could either gain or lose twice as much as it would gain or lose without using financial leverage.

Benchmark: 95% MSCI Italy Small Cap (Gross Total Return - in Euro); 5% ICE BofA Euro Treasury Bill (Gross Total Return - in Euro).

Degree of discretion with respect to the Benchmark: the investment strategy will restrict the extent to which the portfolio holdings may deviate from the Benchmark. This deviation may be significant. This is likely to limit the extent to which the Fund can outperform the Benchmark.

No dividend is payable on the Shares. Income earned by the Fund will be retained by the Fund and will be reflected in the value of your Shares.

Intended retail investor: This Fund is suitable for retail and institutional investors identified on the basis of the following characteristics:

• is an Investor willing to keep the investment for a period of time in line with the Recommended Holding Period; accordingly, the Fund is suitable for Investors with a time horizon long;

• is an Investor who can bear total capital loss as the Fund is not guaranteed and has a medium-high risk class and a medium-high risk tolerance;
• is an Investor looking for capital growth.

The Depositary of the Fund is State Street Custodial Services (Ireland) Limited.

These documents are available in English. The Net Asset Value ("NAV") of the Fund is calculated in Euro. The NAV per Share will be available from the Administrator and will also be published on www.animasgr.it each time it is calculated.

What are the risks and what could I get in return?





The risk indicator assumes you keep the Fund for 7 years, in accordance with the recommended holding period. The actual risk can vary significantly if you cash in at an early stage and you may get back less. You may not be able to sell your product easily or you may have to sell at a price that significantly impacts on how much you get back. The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you. We have classified this product as 5 out of 7, which is a medium-high risk class. This rates the potential losses from future performance at a medium-high level, and poor market conditions will likely impact the capacity to repay the initial capital amount invested. The Fund is considered to have a materially relevant liquidity risk, because you will not be able to sell your product easily or you may have to sell it at a price that significantly impact on how much you get back.

This product does not include any protection from future market performance so you could lose some or all of your investment.

What you will get from this product depends on future market performance. Market developments in the future are uncertain and cannot be accurately predicted.

The Unfavourable scenario occurred for an investment of the product and a suitable benchmark between October 2013 and October 2020. The Moderate scenario occurred for an investment of the product and a suitable benchmark between September 2014 and September 2021. The Favourable scenario occurred for an investment of the product between November 2016 and November 2023.

What are the costs?

Table 1 - Costs over time:

The tables show the amounts that are taken from your investment to cover different types of costs. How long should I hold it and can I take money out early?

Recommended holding period: 7 years The Recommended Holding Period is defined according to the Fund's objectives, investment characteristics and risk profile. You can ask the Fund to buy back your Shares on any business day, in accordance with the provisions of the Prospectus, whether full or partial

repayment of the Shares held is required. Any exit from the Fund before the end of the recommended holding period could have an impact on the risk or performance profile.

There are no early exit costs to pay, however, the relevant Local Paying Agent may charge other expenses.

How can I complain?
