## Direct environmental footprint

ANIMA business, focused on asset management services, has a limited impact on the environment, but it is our firm belief that it must be in any case monitored and, where possible, reduced.



This document analyses the different impacts of ANIMA operations, according to the most common reporting criteria, and in particular to those used in the assessment of compliance with ISO 14001:2015; the company is currently working on the adoption of the procedures and standards to obtain the certification.

# Carbon footprint


We analyse and monitor our carbon footprint, i.e. the emission of CO<sub>2</sub> into the atmosphere, looking in particular at:

## Scope 1




In the last three years, the amount of CO<sub>2</sub> tons per vehicle shows a decreasing trend, also considering the choice to renew company cars with modern engines aligned to best standards in terms of pollution under EU rules.



Concerning **Scope 2**, the data are calculated according to the invoiced use of electricity and converted into CO<sub>2</sub> tons, with reference to the average number of occupants for the offices.


## Use of natural resources



The consumption depends exclusively on the amount used for the buildings in terms of cubic meters per employee; the resource is used to provide drinking water also to avoid the use of plastic bottles, as well as its use for restrooms. As such, no other environmental issue arises apart the use itself of the resource.

## Use of paper




Data refer to paper directly used by the organisation in the offices.

The **FSC** ("Forest Stewardship Council") is an independent, not-for-profit NGO established to foster the responsible management of the world's forests. This guarantees that wood has been harvested in a socially and environmentally responsible manner, tracking all the manufacturing process, from the certified initial source to the end user.

**PEFC**, ("Programme for the Endorsement of Forest Certification") is an international non-profit NGO, dedicated to promote sustainable forest management through independent third-party certification.

## Waste

### ANIMA recycles most of its waste

(aluminium, paper, glass, plastic).

No toxic waste is generated by the Group. "Special" waste produced by the company (printer cartridges) are treated accordingly. No other special or toxic waste is generated by the Group.

We partner with Toshiba Printers in its "Carbon Zero Scheme" project, offsetting the carbon footprint not only including the CO<sub>2</sub> that is being emitted during the production and transportation of such products, but throughout their entire life-cycle.



## Ozone protection

The Group carries out periodical controls on the efficiency of its heating/conditioning systems, ensuring that no substance potentially detrimental to the ozone are dispersed in the atmosphere. In the past three years, no incident occurred.



## Light pollution

The Group is committed to use appliances compliant with the relevant current legislation and, where possible, to use nighttime load capacity dividers for illuminated signs.



No complaints were received for the use of such signs.
