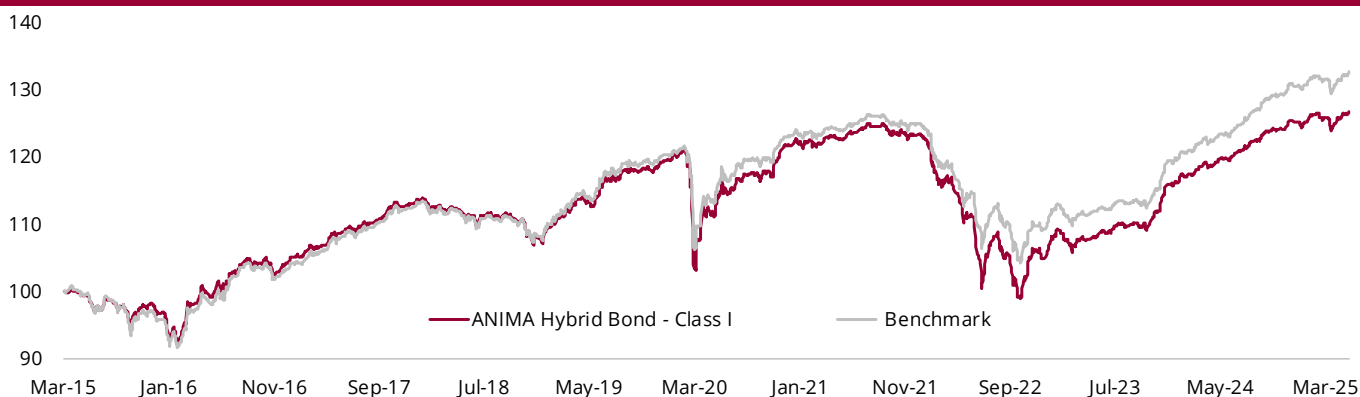

Monthly Fund Manager’s comment

In May, the fund delivered a positive absolute performance and a flat relative one, mainly supported by spreads tightening and the outperformance of European yield curve versus its US counterpart. Following the start of negotiations between the U.S. government and other nations, market sentiment turned more risk-on, prompting a full retracement in spreads to pre-Liberation Day levels for both IG and HY issuers. In this context, we participated in selected primary deals where we identified attractive new issue premiums, with the market showing solid demand for the new supply. We remain highly selective on U.S. and Canadian names, while progressively expanding our coverage universe, with the objective of positioning the portfolio to capture future opportunities.

As of the end of May, the fund maintains a tactical underweight on U.S. and Canadian issuers, which now represent approximately 28% of benchmark. Duration remains slightly underweight relative to the benchmark, although it increased compared to previous month, primarily due to the reduced exposure to U.S. credit. The portfolio's absolute duration stood at 2.85 years.

Corporate bonds accounted for 78% of the portfolio at month-end, driven by the “relatively” compressed sub-senior spread and limited hybrid compensation. Our allocations remain tilted toward countercyclical sectors. Utilities represent 33.5% of the NAV, followed by energy at 20% of the NAV and non-cyclical consumer sectors at 7.7% of the NAV.
